### THE USER AGREES TO THE FOLLOWING CONDITIONS

1. Permission is for *one-time use only*, as described on this form, with no other rights. Any subsequent use (including subsequent editions, paperback editions, foreign language editions etc.) constitutes re-usage and must be applied for in writing to the Vancouver Maritime Museum. An additional fee will be charged for re-use of an image.
2. *All reproductions must be credited to the Vancouver Maritime Museum.*
3. Credits (VMM and photo or negative number if available) should appear in close proximity to the image or in a special section devoted to credits. When known, the photographer should be credited. Crediting of each individual item is mandatory in all cases.
4. With films, filmstrips, or video productions credit for the photograph must appear with other credits at the beginning or the end of the production.
5. With display or exhibition, please credit within the display or exhibition area. Exemption from this requirement must be approved by the Vancouver Maritime Museum.
6. Any alterations to an image must first be approved by the Museum. Accompanying captions must indicate all changes made to the original copy, such as significant cropping, tinting superimposing etc.
7. One complimentary copy of each publication (including film and videotape) in which a photographic copy appears must be sent to the Vancouver Maritime Museum. Please send to the attention of the Librarian.
8. The user may not reproduce or permit others to reproduce the photographic copy or any facsimile of it. Additional copies must be purchased from the Vancouver Maritime Museum.
9. In authorizing the publication of a photographic copy, the Vancouver Maritime Museum does not surrender its own right to publish it, or grant permission to other to do so.
10. The user assumes all responsibility for possible copyright infringement and invasion of privacy arising from use of reproductions.
11. Any exceptions or additions to the above conditions will appear on and be considered part of the License Agreement.
